NARRATIVE

On 03/02/2006 at approximately 1742 hours, I obtained a signed search warrant for 19 Mountain View Drive, East Hartford, Connecticut. The residence is believed to be the home of Alexander Sherrard Bradley [REDACTED], who was involved in a drug related case with East Central Narcotics Task Force, which allowed me to obtain said warrant.

On 03/10/2006, Sgt. Ficara and I decided to drive by the residence listed above, 19 Mountain View Drive, to see if the suspect vehicle. CT. REG. 648TSF, was in fact there. It should be noted that the vehicle is a 1995 Cadillac Deville, color black, and that I had also obtained a search and seizure warrant in regards to the narcotics case conducted with this individual, vehicle, and residence. We were in an unmarked task force vehicle, and had communication with East Hartford Police Department, as both Sgt. Ficara and I are cross-sworn in East Hartford as part of the Standard Operating Procedures associated with East Central Narcotics and all the towns assigned to said task force.

At approximately 2145 hours, Sgt. Ficara and I observed the suspect vehicle, 648TSF, parked in the driveway of 19 Mountain View Drive. Several rooms inside the house had the lights illuminated, while the garage door was wide open. This led me to believe that our vehicle and suspect may be on the move soon, as several surveillance operations have failed due to the vehicle rarely being at the residence. Sgt. Ficara and I immediately radioed task force officers, as well as East Hartford Police Department patrol division, in order to brief and execute both warrants. Sgt. Ficara dropped me off to brief officers, while he returned back and continued to conduct surveillance on our target location.

Sgt. Ficara then notified me that the vehicle was moving and was heading west on Walnut Street. This is a street that is directly off of Mountain View Drive, and happened to be the street that our task force raid van and East Hartford Police cruisers were on. Ofc. Barboza immediately notified the three marked East Hartford Police cruisers, Sgt. Mormino, Ofc. Mona, and Ofc. Sullivan, to affect a motor vehicle stop, which did in fact occur on Walnut Street. All officers were in uniforms, or clearly marked with black "POLICE" Jerseys. The stop was conducted without incident, and the scene was moved back to 19 Mountain View Drive, due to safety concerns.

Upon heading back to 19 Mountain View Drive, I knocked on the front door and identified myself as a police officer. Sherrie Gordon-Shields greeted me at the door, at which point I advised her of the search warrant for her residence and vehicle, and advised her that her son, Alexander Bradley was currently being detained outside. I immediately showed Gordon a copy of "Page 5", which explains to people that a judge has authorized said search warrant, and details what is being sought, and where officers can look. Gordon was extremely cooperative and allowed officers into her home.

Photographs were taken prior to the search beginning, as well as following the search, and the area to be searched was directed to concentrate strictly on the bedroom of Bradley. This is located in the lower level of the dwelling, and consists of a bedroom, computer room, and laundry room. It should be noted that the search warrant allowed for the entire residence to be searched, but that officers were attempting to be the least intrusive possible.

While searching the bedroom of Bradley, several illegal items were recovered. The following is a brief list of all items seized, but refer to the evidence flow sheet for further detail:

- ITEM # 1- Cocaine Residue
- ITEM # 2- \$800.00 in U.S. Currency
- ITEM # 3- One white sneaker containing plastic baggie with 1.28 grams of suspected cocaine
- ITEM # 4- One black Nike Sneaker containing blunting material
- ITEM # 5- Proof of Occupancy for Alex Bradley
- ITEM # 6- One Plastic Baggie containing approximately 2.98 grams of suspected marijuana
- ITEM # 7- Inositol powder, packaging material, razorblade, compact discs with cocaine residue
- ITEM # 8- Plastic baggies

ITEM #10-\$580.00 in U.S. Currency seized off of the person of Bradley subsequent to arrest

Bradley was placed under arrest and transported to Manchester Police Headquarters. Gordon-Shields was advised as to her sons situation and was notified of the contraband recovered. It should be noted that the marijuana and cocaine did in fact test positive for the presumptive presence of their respective drug using the NIK Test Kit "E", as well as the Cobalt Test Drops. Inv. Barboza conducted said field tests. All evidence was logged into evidence in accordance with departmental guidelines.

Once back at police headquarters, Bradley asked if he could talk to me. I asked if he was read his Miranda Warnings, to which he said that he was and that he understood them. I then observed the signed copy identifying that he had his Miranda Warnings read to him. I asked Bradley if he understood them, to which he said that he did. I then told Bradley that I would talk to him.

Bradley was advised as to what was recovered, and admitted to it being his. Bradley said that he was laid off from his previous job, Stanley Steamers, and that he began dealing cocaine approximately 8 months ago. Bradley advised me that he stopped dealing cocaine about 1 week ago, because his "sixth sense" was telling him to stop. Bradley said that he began doing it because he was laid off from his job and needed money. Bradley admitted that he lets his unemployment checks stack up because of the drug sales he makes. When asked why he dealt drugs, Bradley just said that he was stupid and didn't really know why. When asked why Bradley had so much cash on his person and at his residence, Bradley said that he was, "going to the club". Bradley said that once you begin that "lifestyle", referring to the drug money lifestyle, "it is difficult to go back". The \$580.00 Bradley had on his person was in fact seized, as well as the \$800.00 recovered in his dwelling upon the search warrant execution. Bradley then asked if he sold marijuana, to which he explained that he didn't sell any of it, but that he is a "weed-head", referring to being an individual who smoke marijuana consistently.

Bradley was processed and charged with [REDACTED],
